


Group Structure












Company's revenue overview of most recent years




Company's EPS of most recent years



Global Major Furniture Importing Country




- CSIL preliminary data for 2020 show substantial decreases in furniture imports for all the major countries.

Top 10 countries of household furniture imports in U.S. 2019


Leading 10 source countries of household furniture imports in the U.S. 2019

- 拜史上超低利率之賜,美國房地產市場蓬勃發展,房貸也一路膨脹,最新數據顯示,美國第 3 季的抵押貸款激增,一路逼近 10 兆美元、改寫歷史新高。
- 紐約聯準銀行周二(17 日)公布的統計顯示, 7 到 9 月美國家庭負債達到 14.35 兆美元,比前一季增加 0.6% 或 870 億美元,以抵押貸款占比最高。抵押貸款第 3 季攀抵 9.86 兆美元,創新高。
- 這份報告中有許多數字逼近或是打破歷史紀錄,例如第 3 季新屋貸款和再 融資合計 1.05 兆美元,是史上次高紀錄,追平 2003 年再融資熱潮的水準。

- HIGH POINT Demand to fill retail floors is causing a bit of an upheaval of sorts on the bedroom side of the business.
- The challenge is that the demand causes inventory to be depleted on certain groups almost as soon as they arrive in the warehouse, making it hard to pinpoint specific trends in the marketplace.
- Others agreed that demand for bedroom furniture has been quite strong, which is a boost for a category that sometimes gets ignored by many consumers because it's the least visible area of the home, at least compared with the living room or dining room.


December furniture sales see increase, but overall sales in 2020 fall

- WASHINGTON Falling slightly below November levels, furniture sales continued its year-over-year climb in December 2020, up for the month for the fifth month in a row, closing out the year with strong sales, although the sector's sales for the entire year were down.
- The slight dip in furniture and home furnishings sales month to month could be attributed to consumer holiday shopping trends.
- Additionally, many retailers have said that customers are more likely to shop when bolstered with coronavirus stimulus money, and the latest roll out of that began at the end of December and continues into January.
- The year-over-year growth may reflect ongoing consumer demand in the category and interest in home-related projects as people spend more time at home, also seen in the continued year-over-year growth of sectors like building material and gardening equipment.



Malaysia furniture exports in 2019




• Malaysia's furniture exports reached 11.138 billion MYR in 2019, an increase of 13.25% from 2018 (98.3 billion MYR).

- 美國貿易代表辦公室15日公佈對越南匯率政策的"301調查"結果,稱與越南貨幣估值相關的行為和政策整體看來"不合理"且限制美國商業活動。但美方未宣布關稅懲罰措施。
- 美國財政部上月曾發布報告,將越南列為"匯率操縱國",指責越南干預匯率以在國際貿易中獲取不公平競爭優勢。越南央行回應稱,越南管理匯率是為確保宏觀經濟穩定。
- 美國貿易代表辦公室說,美方目前不會針對上述調查結果採取任何具體措施, 但會繼續評估所有可用政策選項。
- 美國貿易代表萊特希澤在聲明中說,導致貨幣價值低估的"不公正"行為和 政策傷害美國工人和企業利益,希望美國與越南能找到解決美方擔憂的出路。

- In a special announcement on 11 Jan 2021, Prime Minister Tan Sri Muhyiddin Yassin began by stressing how bad the COVID-19 third wave is affecting Malaysia, with daily 4 digit cases being recorded since end November, even reaching a new high of 3,027 cases just a few days ago.
- He announced that the Movement Control Order (PKP) similar to the one we all faced in March 2020 will be implemented for 14 days from 13th January 2021 26th January 2021 in 6 states across Malaysia: Penang, Selangor, Wilayah Persekutuan (KL, Labuan & Putrajaya), Melaka, Johor, Sabah.

貨櫃海運 旺到明年上半年

- 全球貨櫃海運市場搶櫃搶到完全失控,市場運價與預估值完全脫鉤, 今年出現飆漲走勢。國內航運專家指出,「缺船、缺櫃及碼頭缺工」 等三缺情況如無法改善,海運市場需求熱絡情況明年上半年都看俏。
- ■海運專家認為,針對報告可看出,對明年海運貨櫃市場貨量需求展 望偏樂觀,需求量較今年增加,雖然新船也增加,然新造櫃訂單都 是9月以後才較熱絡,新船必須有櫃搭配,新年度貨量增加,恐怕也 會因缺櫃無法消化,要等新造櫃加入,市場才會緩解,就目前情況 研判,明年三缺情況上半年都無法立即解決。
- 另外,之前很熱絡的北美航線近期也出現塞港情況,美國新冠確診病例突破1,900萬例,導致碼頭作業難度拉高,貨櫃滯留碼頭時間拉長,貨櫃問轉天數增加,上海出口至美西、美東基本港市場運價分別為每40呎櫃4,080美元、4,876美元,其中美西航線上揚4.6%,美東航線較上期持平。
